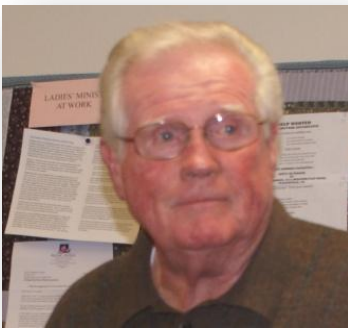
GCW Newsletter Brief:

V-Show-N-Tell (6 Members):

Here's my newsletter submission. It is a slice of Olive wood tree trunk end grain that I inlaid into a piece of Hawaiian KOA wood. The slice was glued to a piece of Birch PSA veneer to stabilize the slice. I then used my Dremel router and a 1/16" bit to route out the shape in the KOA. I then used my Plunge router to remove all the rest of the inlay area. After the inlay was glued into the KOA I used C/A gap filler to fill in the edges and some of the cracks in the olive wood. Then the piece was sanded on a flatbed sander and leveled out. The finish is 1 coat lacquer sanding sealer and then about 5 coats of Watco rattle can lacquer. This was my 1st attempt at doing this so it's not perfect and was definitely a great learning experience. I've hung it on a wall in the house.

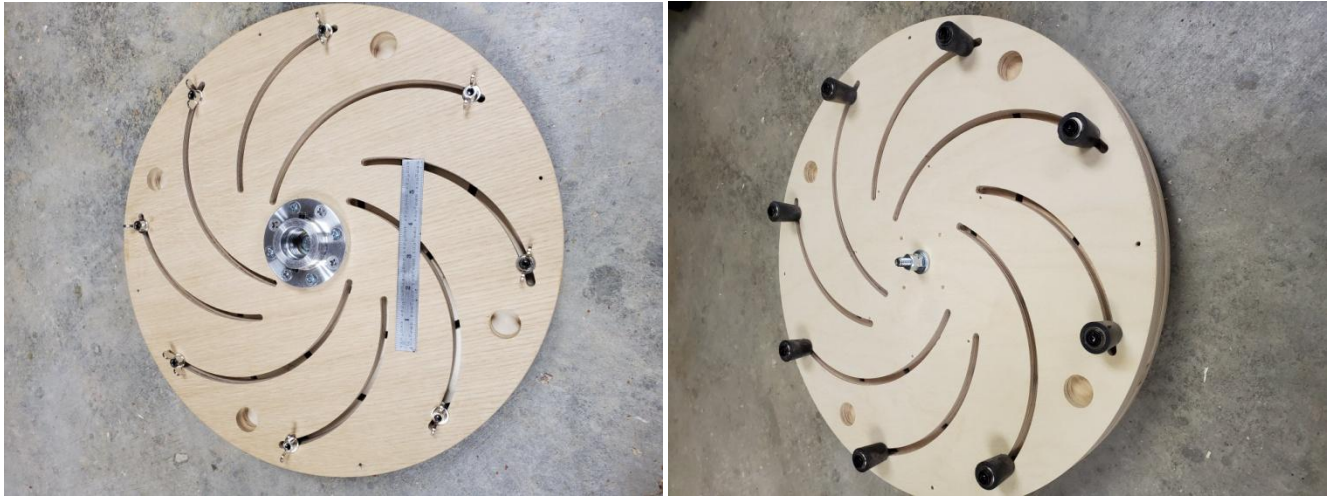

This is a 15 1/2" Longworth chuck I just completed for lathe bowl work. It is made of 1/2 inch Baltic Birch and 3/4 inch oak ply wood with a commercial hardware kit and face plate from Rockler. I did use the chuck on the small bowl shown in last month's show n tell to finish the bottom. It seems to work fine, however time and more bowls will prove it out one way or another. My next bowl should give it a good work out, so I will then know more about how it performs, hopefully by the next meeting. I have been debating if I should put some kind of finish on it or leave it bare?

I needed to strip a cherry side table and refinish it to Walnut to match living room decor. I stripped the original finish using a putty knife, Klean Strip Stripper and a mineral spirit wash. I then applied a darker walnut stain, and finished it using the General satin Armor Seal oil based finish. I included a photo of items used.

Here is some background on my desk project. It is all Cherry, with Alder and Baltic Birch internal support. There are 2 secret compartments and a keyboard tray using a drop down false front. It utilizes a neat joint I wanted to try for years and saw an opportunity to do so in this project. The finish is 2 to 1 shellac thinned with alcohol to prevent blotches, custom mixture of stain, (cherry gel and cherry Zars) and a custom blend of wiping varnish to finish, one part varnish three parts mineral spirits.
